**HEALTH AND SOCIAL SCIENCE RESEARCH**

- **CDC Zika Monitoring and Evaluation** – A two-part study with one part consisting of an 18-month monitoring and evaluation effort focused on social science research to determine changes in social attitudes and access to contraceptives as part of the fight against Zika. The second part was a study to determine how long the Zika virus persists in the blood (persistence of viremia). We conducted this project in Puerto Rico, requiring both Spanish and English capabilities.
- **Army Research Institute: Role Transition from Team Member to Noncommissioned Officer (NCO)** – Assembled a team of scientists, innovative thinkers, and former military personnel to examine what the transition process from Soldier to NCO is like, identify challenges or barriers to a successful transition, and recommend solutions to address these challenges. This study resulted in a comprehensive plan of how the Army could change current programs to provide better training and development of junior Soldiers to enable them to more readily and capably make the transition from team member to team leader.
- **USDA/USAID/DEA Value Chain of Cashews and Mangoes in Cambodia** – An econometric study of the value chains of cashews and mangoes in Cambodia to develop a road map of the mango and cashew value chains in Cambodia. This included research on the value chain of the two agricultural commodities. The study determined how much change had occurred in the value chain with respect to US efforts over the past two years.

**FINANCIAL MANAGEMENT**

- **Defense Health Agency (DHA)** - TSI Federal assists DHA with managing related projects, with the intent of improving the DHA and Military Health System (MHS) financial performance. TSI Financial Analysts define, plan, implement and integrate aspects of complex financial programs; as they relate to the DHA or the MHS. We provide accounting, auditing, and financial management support to respond to the needs of FEMA, the WYO companies, other contractor staff, auditors, and other stakeholders in the operation of the WYO Program. Support includes finance operations support, records management support, accounting and financial management support and control, financial audits support, financial strength rating support, and actuarial services.
- **Financial Management and Advisory Services** – Provide the US Agency for International Development, Bureau for Management, Office of the Chief Financial Officer with voucher examination, accounts reconciliation, payroll, risk assessment, financial management and advisory services. **PROGRAM MANAGEMENT**

- **DHA** - TSI Federal provides extensive administrative support to the DHA Administrative and Management Directorate. Our Executive Assistants assist with the planning, preparation, and execution of travel requirements. To include the timely entering the travel request into the DoD Travel System. We also provide schedule management which includes arranging meetings, conferences, speaking engagements and other appointments for civilian/military customers.
