Defense Health Agency (DHA) Executive Administrative Support

TSI Federal provides extensive administrative support to the DHA Administrative and Management Directorate. Our Executive Assistants assist with arranging travel, compiling data for reports, creating presentations, and performing records management. We also provide schedule management support which includes arranging meetings, conferences, speaking engagements, and other appointments for civilian and military customers.

Department of Justice (DOJ) Background Investigations and Clearance Adjudication Support Services

TSI Federal reviews, evaluates, and adjudicates background investigation reports and other records to validate background investigations. After conducting investigations, we recommend that security clearances be granted, suspended, revoked, or denied. We also provide administration services for the department.

Department of Energy (DOE) Office of Indian Energy (OIE) Tribal Support Services

TSI Federal provides writer/editorial support; communications support; tribal engagement, outreach, conference planning and administrative support; and conference and event planning services.

Missile and Space Intelligence Center (MSIC): Logistics, Warehouse, Access Control, and Escort Services

Our team provided logistics support, financial support services, security specialists, intelligence support, mail screening security services, personnel security, and Special Access Program Facility (SAPF) or Sensitive Compartmented Information Facility (SCIF) security administration to MSIC.

Department of Homeland Security (DHS) Countering Weapons of Mass Destruction Office: Technical Assistance Team Support (TATS)

TSI trained first responders, mostly FBI agents, on the use of technical equipment designed to detect weapons of mass destruction a part of natural and man-made incident responses. Our team procured, stored, transported/shipped, and handled training materials and provided operation assistance to the FBI Hazardous Devices School at Redstone Arsenal.

Federal Emergency Management Agency (FEMA): National Flood Insurance Program Financial Management Services

Our team provides all accounting and financial control functions for the National Flood Insurance Program. We provide support for records management, accounting, financial management, reporting, and audits. We also provide actuarial support to review and analyze FEMA policy and rate setting responsibilities.

National Aeronautics and Space Administration (NASA): Operations and Programmatic Support Services (OPSS)

Our team provided administrative, professional, and communications support services across a wide range of activities at NASA Headquarters while managing a team of experts on high visibility programs. We managed four subcontractors including one large significant subcontractor.

US Army: Electronic Warfare Training and Range Support Services

This contract focused on developing training materials, modifying existing training materials, providing instructors for cyber warfare/electronic warfare (EW), and analyzing the results of the training.
